Achieve funds support educational excellence, innovation and equal opportunity for all students through enriching programs that exceed the limits of public school funding. Grants are given for 50-60 classroom and school-wide projects annually, new technology, pilot programs, etc. in all subject areas. The Michele T. Riecke Teaching Fellowship pays for summer professional development for educators. The Columbia High School Auditorium initiative expanded the school district's 2014 renovation of the 1,100 seat venue to a complete restoration.****4b** (Code:) (Expenses \$ **38,910** including grants of \$) (Revenue \$)**The Achieve Volunteer Tutor Program is funded jointly by the foundation and the school district. It recruits, trains, assigns and supports 259 volunteer tutors, who provided academic assistance to 289 students who are at academic risk and/or from families with financial need. Working alongside the school district's academic intervention program enables Achieve to tailor the tutoring to the specific needs of the tutees.****4c** (Code:) (Expenses \$ **346,798** including grants of \$) (Revenue \$)**Beyond the Bell is an after-school program that provides high-quality enrichment classes that are aligned to the district's curriculum and can expand and extend classroom learning with the benefit of extra time. Classes are focused on specific learning needs and are taught by highly-trained teachers. The program offers an array of classes in the arts, sciences and humanities, with particular emphasis on STEAM (science, technology, engineering, the arts and mathematics) education. It also offers small-group tutoring and homework classes for students needing support on grade-level skills.
