Achieve Foundation Board of Trustees: Twenty four board members provided oversight for the organization's operations. They also participated on various committees to plan and carry out the foundation's work (fundraising, funds distribution, events, grant programs, communications, financial recording, etc.)

Achieve Volunteer Tutor Program: Training was offered to 375 volunteers, who provided academic assistance to students in the School District of South Orange and Maplewood (NJ). Tutors gave an average of 20 hours of service over the course of the fiscal year.
